CAMPUS CLASSROOM MASTER PLAN

It is still very early, but Academic Affairs has initiated a study that will be looking to address several key issues, as it relates to our classroom spaces.

- Enrollment growth trends
- Shift from reactive to a proactive approach in meeting instructional space needs over time
- Optimize the ratio of traditional to active learning spaces
- Teaching and learning technologies that are rapidly emerging (classroom of the future)
- Blurring of formal and informal teaching and learning spaces
- Connection of physical to virtual classroom models (distributed model)
- Flexibility to adjust for long-term needs (scenario planning)
- Strategy for addressing space needs: new space vs. renovation to improve the quality and to right-size existing space
- Governance/policy improvements to the management of instructional labs (college/department assets vs. university assets)
