ACADEMIC SPACE RESERVATIONS (PRIOR TO ADD/DROP)

We want to make you aware of a change to the room reservation processing window, for requests made to Conferences, Reservations, & Event Services (CRES), effective with the Spring 2025 term. These changes are applicable only to academic classrooms.

- CRES can continue processing academic department room reservation requests leading up to the add/drop deadline for the term, but these are still tentative and subject to change.
- CRES will now process classroom reservations for **student and non-academic** room requests <u>after</u> the add/drop deadline. As our class and student numbers continue to increase, we need access to as many classrooms as possible until that point. (400+ initial/change requests in fall/spring terms leading up to add/drop)
 - If the student/external group requestors wish to appeal that stance, they can appeal directly with our <u>scheduling/registration team</u>.
- For all requests (student, academic department, external groups) we are asking that single use and/or recurring requests end on Reading Day for fall/spring terms and the last day of class for summer terms. This is to ensure those spaces are available for exam scheduling, an independent room assignment process whereby academic space is needed for extended meeting periods to accommodate final exams and ensure noise levels remain optimal for examinations.
