#### **Articulation Agreements**

Please note that articulation agreements that are older than two years will expire on December 31, 2025. The new UNC System Office Transfer Regulation requires all agreements to be reviewed every two years and will be maintained at the UNC System Office, alongside all other UNC campus articulation agreements. If you have a current agreement in place, you may want to begin review in the fall. The Office of the Registrar maintains domestic agreements (found <a href="here">here</a>). International Programs maintains international agreements. All agreements should be updated to include a 2-year review cycle.

### New Agreement Definitions/Changes:

**Bilateral Agreements -** Agreements between one university and one community college **Multilateral Agreements -** Agreements between one university and more than one community college

**Uniform Agreements -** Agreements that focus on specific degrees or disciplines **AAS Degree Completion Programs -** Formerly known as 2+2 programs; Name change represents the degree the student is bringing, but also not committing to a 2 year timeframe for completing their baccalaureate.





#### New Grade & LDA Change Request Solution (eff July 15, 2025)

A new grade and last day of attendance change request solution went into effect on July 15 to replace our previous solution that had reached its end-of-life. This new solution is the culmination of a year's worth of collaboration amongst many partner offices, including OneIT. This new solution is also the first to utilize **ProcessMaker**, a new enterprise-wide platform. There are other projects currently underway that will be utilizing ProcessMaker as its foundation.

#### **Provisional Transfer Credit & Credit for Prior Learning**

Provisional transfer credit may be granted for study at foreign institutions or a college or university not accredited by an accepted accrediting body, but must be validated by 30 credit hours of successful performance in residence at UNC Charlotte.

This is a small reference within our Transfer Credit and Advanced Standing policy that is often overlooked. The Office of Undergraduate Admissions articulates international transfer credit for the University. All foreign transfer credit is applied under this provision. Occasionally, we receive domestic transcripts from institutions that are not regionally accredited. In such cases, we will review their transcript to determine if the coursework aligns with our institutional programs. If applicable, we will extend credit on a provisional basis. Credit for prior learning is currently also covered under this provisional rule. While the Associate Deans Council is working to develop a prior learning evaluation policy, we do accept some credit for prior learning currently, under this policy. We would like to thank our academic department partners and content experts for their assistance in reviewing these courses/trainings/certifications.
