To ensure a smooth and efficient workflow, please be mindful of petitions that have been resolved before they reach the Office of the Registrar. If a petition has already been addressed, please deny it and add a comment that explains how the issue was resolved.

Denying the petition in this manner is a critical step. It prevents the petition from clogging our queue and avoids unnecessary processing time for an issue that has already been fixed. The term "deny" in this context can also indicate that the petition's pathway to resolution is no longer needed.

Example:

A student submits a petition for a registration override, but an override was provided directly to them, and they are now registered for the class. Since the issue is already resolved, there is no further action required by the Office of the Registrar. In this case, you should deny the petition and add a comment explaining that the student was granted an override and is now registered.

Language Exchange and Elementary Mathematics Education Add-on Licensure (EMAOL) Platform Sunset

We received a letter from the UNC System Office today (9/2) that the platform that supports these two initiatives is sunsetting at the end of the spring 2026 semester. Registration after spring 2026 will not be available.

So, what does this mean? While the EMAOL was niche, the Language Exchange opened the opportunity for students to pursue any language offered by any UNC campus and streamlined both the registration and grade sharing. This was at no additional cost to the student. Starting next fall, students will need to apply, pay an application fee, register, and request (pay) for a transcript to be sent to Charlotte to pursue a language sequence not offered at Charlotte.

Point of Reference: This is the same platform that was used to orchestrate UNC Online a few years ago. While UNC Online sunsetted back in 2022, the platform continued to manage course sharing for students/institutions for the Language Exchange and EMAOL.

Non-Standard Meeting Patterns for Courses

Courses scheduled at non-standard times will be processed on a "space available" basis, AFTER confirming courses have been scheduled. The Office of the Registrar enforces this Charlotte policy, and room assignments for course sections scheduled during the university's standard meeting patterns will be given priority.

Prime Time vs. Non-Prime Time

A minimum of 40% of classes must be scheduled during non-prime time. Non-prime time is defined as classes starting before 9:05 a.m. and late afternoon classes with start times at or after 2:30 p.m. This portion of the policy is enforced by your College's Associate Dean.
