Student Program Change (SPC) Timeline (New)

Starting Spring 2026, Charlotte will introduce a new timeline for student program changes (e.g. change of major, minor, catalog year, etc.). This new timeline is a necessary part of the University's ongoing CPoS implementation. To ensure accurate CPoS eligibility determinations for financial aid purposes, all student program changes must be submitted no later than five (5) business days before Census, as defined on the official Academic Calendar, for each regular semester (Fall and Spring). Program changes submitted after that deadline will still be processed; however, they will not be reflected in CPoS aid eligibility until the following term. The deadline to submit SPC's for Spring 2026 is January 16, 2026.

Process for General Ed. Exemptions for Out-of-State AA/AS Degrees (New)

Beginning in Spring 2026, UNC Charlotte will grant a general education exemption to both new and readmitted students who meet the following criteria:

- Degree Type: The student has earned an Associate in Arts (AA) or Associate in Science (AS) degree.
- Accreditation: The degree must be awarded by a regionally accredited institution in the United States. (International associate degrees are not included.)
- Verification: The degree must be officially conferred and documented on the student's final transcript.

This exemption applies only to students who enroll or are readmitted beginning Spring 2026 or later and does not apply to students who enrolled prior to this date.

Academic Forgiveness Applied Earlier (New)

Beginning in Spring 2026, Academic Forgiveness will be applied following the Last Day to Add/Drop. Previously, Academic Forgiveness was applied following Census. The earlier date was requested by the Advisor Leadership Council in support of CPoS.

Grade Replacement Update (New)

As of October 17, 2025, Charlotte has launched an all-new Grade Replacement tool! This upgraded system replaces our previous solution, offering students a better experience with updated technology. See the updated Student User Guide and FAQs.

UPDATE: Academic Calendar

Beginning with the Spring 2026 Academic Calendar, the date for "Student registration appointment times available on web" will be the business day after the final grading due date for the First-half term (H1). This allows student's earned credit to be applied after the end-of-term processing is complete, resulting in an accurate registration time ticket day and/or time.

Pursuant to this change, the "Student registration appointment times available on web" date, on the Spring 2026 Academic Calendar, has been updated to March 6th for Summer/Fall 2026 registration.
