Now is a great time to update your Grade Change Approvers for Fall 2025 Final Grade Change reviewers! Deans, Associate Deans, Assistant Deans or Department Chairs may submit a Grade or Last Date of Attendance Change Approver Update Request Form to request updates to their department's Grade or Last Date of Attendance Change approver roles and routing. The current database is not contained in Banner and is maintained separately. This is different from previous semesters. To prevent unnecessary delays, please submit your requests prior to the Winter Break.

# Campus Student Program Changes, Substitutions, and Waiver Rhythms (New)

In preparation for CPOS, Charlotte is introducing new best practices and timelines for Student Program Changes (e.g. change of major, minor, catalog year, etc.) as well as for Substitution and Waiver academic petitions.

Student Program Changes (SPCs), Substitutions, and Waivers should now be submitted during registration for the upcoming semester. The last date that an SPC, Substitution, or Waiver may be submitted for Spring 2026 is January 16, 2026 (five business days prior to census). SPCs, substitutions, and waivers submitted after this date will still be processed; however, they will not be reflected in the student's CPOS aid eligibility until the following term.

#### **Study Abroad Petition Short-lived**

During our Fall 2025 Registrar Forum, we shared that a new Education Abroad Petition was created and in production with the support of the Office of Education Abroad (EA). Since that time, circumstances within EA have changed, and this petition is being permanently shelved. Some students had already initiated requests using the new petition. Those students have been contacted and asked to initiate directly with the EA. We apologize for any misinformation, and students should follow the guidance on the EA website.

#### Academic Suspension Appeal Reconsideration - Academic Advising Question (New)

New feature alert! To encourage students to be thoughtful about the decision they make regarding their one-time reconsideration appeal, we've added a non-mandatory question that we hope will prompt students to connect with their academic advisor prior to making a decision. The response will be recorded on the reconsideration appeal form, for department approvers to see. By answering "no," it will not stop the student from proceeding; however, if they choose "no," they can close out and it will not count towards their one-time reconsideration appeal. Again, our hope is to simply recommend the meeting, but it is not mandatory.
